Disney Family Holiday Celebration Tickets will be valid for use for the period of October 13, 2019 – February 13, 2020\*.

\*Block-out dates apply. Please visit **blockoutdates.disney.com** for theme park block-out dates. Block-out dates may change at any time, and you are responsible for checking updated information prior to your visit. Admission to theme parks, water parks and golf courses are subject to capacity, availability, and other restrictions, including the rules, entitlements and procedures of the Complimentary Admission and Discounts Policy and the Disney Family Holiday Celebration Program in effect from time to time.

Eligible Employees and Retirees or spouses/domestic partners of eligible Employees and Retirees:

Before entry:

- Gather your entire party and all admission media before proceeding to the park entrance.

Eligible Employee or Retiree MUST be present to admit all Guests.
- If the spouse/domestic partner of an eligible Employee or Retiree is admitting guests, they
  will present their government-issued photo ID, their Spouse/Domestic Partner Pass and
  the Disney Family Holiday Celebration *Disneyland®* Resort Primary Ticket along with one
  (1) Disney Family Holiday Celebration Guest Ticket for each of their Guests. Eligible
  spouse/domestic partner MUST be present to admit all Guests.
- 3. Present one (1) Disney Family Holiday Celebration Guest Ticket for each of your Guests
  - Disney Family Holiday Celebration Guest eTickets or plastic entry tickets must be used in conjunction with the *Disneyland®* Resort Primary eTicket or plastic entry ticket at *Disney California Adventure®* Park.
  - Any eTickets (printed or displayed on a mobile device) will be exchanged for paper tickets.
  - All tickets MUST be used on the same day at the same time. Any unused tickets after the first-time entry will be voided and no longer valid for use.
  - Each ticket may only be used by one Guest for one day.
- 4. Your Guests should enter immediately after you enter.
- 5. To re-enter *Disney California Adventure*<sup>®</sup> Park on the same day, the Employee, Retiree or their spouse/domestic partner will need to present the paper ticket they were issued when they first entered the park along with their Company-issued ID, or government-issued photo ID along with Spouse/Domestic Partner Pass, respectively. Their Guests must present the paper ticket they were issued when they first entered the park. Valid photo confirmation will also be required at the time of re-entry.
- 6. At the same time that you use your Disney Family Holiday Celebration tickets, you may also use your Main Entrance Pass or your One-Day Park Hopper® Guest Tickets for additional admissions into the theme park(s) on days when your Main Entrance Pass or One-Day Park Hopper® Guest Ticket is valid. Please note when using both your Main Entrance Pass or One-Day Park Hopper® Guest Tickets along with your Disney Family Holiday Celebration tickets that there is only one admit for yourself or your spouse/domestic partner. You or your spouse/domestic partner will be admitted using the Disney Family Holiday Celebration Disneyland® Resort Primary ticket.
